# **Recent burglaries**

PCSO Julie Pardoe reported to the Council that over the weekend of the 24<sup>th</sup> and 25<sup>th</sup> October we had four burglaries which all took place in Bredon. Two of the burglaries occurred in Blenheim Drive, one in Vallenders Road and the fourth in Cherry Orchard. It is believed that at least one the burglaries could have occurred as early as 9.30pm on Saturday evening.

The Safer Neighbourhood Team are urging all residents to leave a light on timer when going away from the property during the evening and early morning, making sure the house alarm is functioning properly and set, and securing all windows and doors making sure any keys are removed from the locks. One of PACT's priorities is to reintroduce the neighbourhood watch scheme in the parish.
