New Homes Bonus Applications

The Council was really pleased with the number of applications received. Twelve proposals had been received far exceeding the £12,971 allocation; after long discussions the Council made the following decisions:-

Outward Bound Association - The association having already received £1,000 from the 2014-2015 allocation, was rejected, however the application will be carried forward to the 2016-2017 allocation, to be decided later in the year.

Rugby Club Bridge - The bridge being on private land was rejected.

Installation of lights - between the car park, bowls club, football & rugby changing rooms plus painting of bollards in the car park - £1,200 was allocated.

Playing Field Storage Facility - Organised by the Rugby club on behalf of themselves and BCPR - £3,700 was allocated.

First Bredon Scout Group - £1,000 was allocated for camping equipment.

Sailing Club - £1,000 allocated to enable the purchase of a junior sailing dingy.

Bredons Norton Village Hall - Central Heating Boiler - £1,446, half the cost of the boiler, was allocated.

Friends of Bredons Handcock - New Bell Boat. The rules set by Wychavon do not allow the council to donate to the school.

Bredon Community Care - £600 was allocated for the servicing of wheelchairs.

Making a dangerous corner safer - by widening the footpath between Bredon and Westmancote a stretch of 65 metres. £3,000 was allocated for the hedge to be removed and a new hedge planted further back from the road.

Installation of a Footpath along the Eckington Road - from opposite the playing field entrance to the public footpath entrance. We are awaiting a quote for this work therefore this application will be included in the 2016-2017 allocation.

Bus Shelter for School Bus by Jubilee Car Park - Not feasible as it would set a precedent of all the school 'pick up' points.

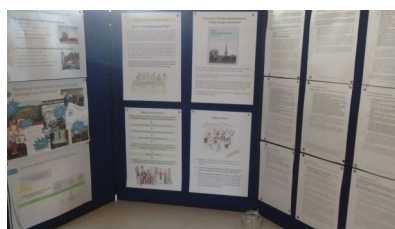
A combined application called 'Bredon Community' for £11, 946 will be completed by the clerk and submitted to Wychavon for their approval. Clerk to notify all applicants.
