

Bredon, Bredon's Norton and Westmancote Parish Council

The minutes of Bredon Parish Council meeting held at Bredon Village Hall on Monday 1st June 2015 at 7.15pm.

In Attendance Ms J Shields (Clerk), Mr Peter Whitehead, Cllr Hardman (County and District), and three parishioners.

Cllr Rhodes signed his Declaration of Office.

Mr Whitehead updated the council on the potential development site at the rear of Perwell Close.

Two Kinsham residents are concerned at the planning application for the change of use GPDQ/15/01199/GPDQ in Kinsham.

1. Apologies For Absence.

Apologies were received and accepted from PCSO Tinkler.

2. Election Of Vice Chairman.

Cllr Falvey proposed, Cllr Whiting seconded and it was unanimously agreed to elect Cllr Rhodes as Vice Chairman.

3. Declaration Of Interests.

Cllr's were reminded to update their Register of Interests with Wychavon. Cllr Darby declared an ODI in item 13a.

a) To Consider Application For Dispensation.

The council agreed to Cllr Rhodes application for dispensation to discuss the Precept.

4. To Consider The Adoption Of The Minutes Of The Meetings Held On The 13th April 2015 And 11th May 2015.

The minutes having been previously circulated were agreed and signed as a true record.

6. To Discuss Reviewing Council's Standing Orders.

7. To Discuss Reviewing The Council's Financial Regulations.

8. To Review The Councils Risk Assessment.

Cllrs Falvey and Sly will review the Risk Assessment, as changes need to be made.

10. To Discuss Memorials Within The Parish.

Councillors were asked to observe and record benches and any other memorials that they see in the parish, with a view to keeping a record, councillors are also asked to recommend positions for memorials in the future and to report back to the next meeting.

11. To Discuss Change Of Common Land Register.

The council agreed to implement the necessary changes to the Common Land Register, Clerk to contact the Land Registry at County Hall, Cllr Darby and the clerk to prepare the documentation.

12. To Consider The Parish Councils Use Of IT.

Construction of two new dwellings plus improved access. The council agreed to object to the proposal.

Change of use from Farmyard to commercial vehicle parking (retrospective)
The Parish council is not aware of any strong planning policy grounds for objecting to the proposal. This response is a general observation and should not be taken as objecting to or supporting the application.
- III. W/15/01355/PP The Croftlands, The Lane, Bredons Norton, Tewkesbury, GL20 7HB
Demolish existing flat roof garage and extension and replace with pitched roof side and rear extension with bedrooms over. The Parish council is not aware of any strong planning policy grounds for objecting to the proposal. This response is a general observation and should not be taken as objecting to or supporting the application.
