March 2017, Issue 43 Neighbourhood Plan Update

The Neighbourhood Plan has now completed its independent examination, and we are pleased to report that it has been approved subject to a series of recommended modifications. The examiner found that the plan was fit for purpose, and he was satisfied that it promoted sustainable growth and set out a positive vision for the future of the parish. He complemented the wider community and the Parish Council for spending considerable time and energy in identifying the issues and objectives covered by the plan.

At the heart of the Plan are a suite of policies aimed at safeguarding the character and appearance of the parish and maintaining the gaps between villages. Before it is finally adopted, the plan must be approved by residents in a parish-wide referendum. This is expected to take place in June.

Local Transport Plan

A response has been submitted by the Parish Council to Worcestershire's recent consultation on the latest version of the Local Transport Plan. Naturally this document concentrates mainly on large road schemes within the county, the most relevant to Bredon being plans for improving the A46 southbound from Evesham and the possibility of a new link to the M5. This would bypass the Ashchurch Road thus reducing the chronic congestion suffered by motorists during peak rush hour.

On the railways plans are progressing for Worcester Parkway station which is to be built near to the village of Norton at the intersection of the Birmingham-Bristol and Hereford-London lines. Planning approval has been granted and work at the site is due to start soon.

We continue to lobby for improved bus services through the parish, particularly for a direct link with Worcester, and a keen eye will be kept on developments in electric vehicle technology to ensure that Bredon is not left behind when it comes to the necessary infrastructure.
