Roadworks on road to Eckington

The Parish Council would like to apologise for any inconvenience caused by the traffic lights on Moreton Lane (B4080) which will be in place during early September. It is so a new footpath can be installed from the Playing fields to the start of the footpath which runs across the fields to Westmancote.

Grazing Land available

The land known as Glebe Field, Tewkesbury Road, Bredon is available to rent for grazing without water. It measures approximately 0.327 hectare (0.81 acre) and costs only £105 for 12 months. This field would be ideal for someone with livestock.

Parish Tree Warden: Carry out tree inspections and liaise with Wychavon District Council and Worcestershire County Council to oversee Tree Preservation Orders.
