Update on Proposed Development at Mitton Bank



By now you may have visited one of the two information days held by TFA (Tristran Fitzgerald Associates on behalf of Mactaggart & Mickel and Barratt Homes) on 12th and 17th October, outlining a proposal for 500 new homes in the parish between Bredon's Hardwick and Mitton. These are not part of an official consultation and any comments submitted by residents at this stage will not have a significant bearing on the outcome.

The development site is **not allocated** for future housing in the South Worcestershire Development Plan (SWDP), which together with the recently adopted Neighbourhood Plan, controls development in Bredon Parish. However, Tewkesbury Borough is seeking to include Mitton Bank in its emerging development plan, the Gloucester-Cheltenham-Tewkesbury Joint Core Strategy (JCS), citing the government's 'duty to cooperate' across borders. The JCS is currently undergoing an *Examination in Public* overseen by a government inspector, and her final report will have a strong bearing on whether this development goes ahead.

As things stand, the TFA proposal is in conflict with the new Neighbourhood Plan, which stipulates that development should be strictly limited to sites allocated under the SWDP. The Parish Council remains strongly opposed to this development, and will be doing everything it can to ensure that the Neighbourhood Plan is upheld. It believes that any new housing at Mitton should only come forward through a formal review of the SWDP. This is the best way of ensuring that new development is properly integrated with existing infrastructure and services, and that local people are consulted on the alternatives. We will continue to keep parishioners updated as more information becomes available.

Burglaries in Bredon - Advice

- Security mask your property with your postcode in permanent marker or use a property marking system such as Cre Mark or Smartwater.
