
### **Ashchurch Bridge - Judicial Review**

You may be aware that in March of this year, Tewkesbury Borough Council decided to grant itself planning permission for a bridge over the Bristol to Birmingham rail line. The bridge is to be sited between our Parish and the Parish of Northway.

The project is identified by Tewkesbury Borough Council as being the key to delivering the Tewkesbury Garden Town, with the bridge intended to enable the delivery of thousands of new homes to the north of the Ashchurch Ministry of Defence site.

The granting of planning permission was despite Bredon Parish Council and all other surrounding Parish Councils, along with many concerned locals who responded to the consultation, objecting to the proposed bridge.

The reasons for objection included concerns over the implications on highway infrastructure, flooding and environmental impact, with much of the

key information that would usually form part of an application, to enable proper and detailed consideration of these key aspects, not being presented & therefore considered by Tewkesbury Borough Council, as would typically be required with applications of this scale and implications.

Consequently, Bredon Parish Council has been collaborating with other Parish Councils in seeking leave from the High Court for a Judicial Review over this planning decision. We are pleased to report the Court has agreed to review the planning application. This does not mean that the decision will necessarily be overturned, but it shows that there are reasonable grounds for believing that the application process did not follow the law. This will now be tested in Court.
