W/22/01214 - The Croft, 1 The Dell, Bredon. The Parish Council note the alteration to plot 2 to reduce its width by the removal of the car port & room above from the side of the proposed property. As previously stated, the Parish Council agrees with the pre-application advice that a single dwelling would be more appropriate rather than the two as proposed.

Planning Inquiry - Mitton Bank

We realise it is all a bit confusing, with the same application at Mitton Bank being in the SWDP review (above) and the same area going to Planning Inquiry in October. We are hoping for a decision before the end of the year, or in early 2023.

The Parish Council acted as a Rule 6 Party to defend the decision reached by Members of Wychavon District Council's Planning Committee to refuse the planning applications for 500 homes and a primary school. In doing so, the Parish Council argued the importance of local plans and their policies including the Bredon Neighbourhood Plan, when deciding planning applications. The Parish Council engaged a team of professionals to demonstrate the problems that exist with the applications, including a Barrister, Solicitor, Transport and Landscape Consultants, who ably demonstrated the flaws that exist with the Developers application and supplementary documents.

We are very fortunate that local residents are so invested in their area and planning matters, which led to a significant number of local residents attending the hearing to make representation of the various issues that concerned them about these applications. The Parish Council also wishes to thank our District Councillors Adrian Darby OBE and Adrian Hardman for their contribution in giving evidence at the inquiry.
