W/22/01945/HP The Cottage, Chapel Lane, Westmancote, GL20 7ER Alteration, refurbishment and extension of residential dwelling, including alterations to garden boundary treatment and provision of new vehicle access off Chapel Lane. Objection, letter to be forwarded to Wychavon Planning covering the dominating scale and the impact on neighbouring properties and heritage assets. Also non-compliance with Neighbourhood Plan and development plan policies. Refusal recommended and the property plan to be redrawn in line with the Bredon Parish Neighbourhood Plan.
- iii. W/22/02068/FUL Polhawn, Dock Lane, Bredon, GL20 7LG *Proposed Replacement Dwelling.*

- c) Other Planning Matters.
 - i. SWDP Consultation:

The parish council's detailed response to the SWDP Consultation will be published on the website and social media to enable parishioners and the public to assist them with responses. The December consultation deadline has now been extended from 13th to 23rd December 2022. It was the view of Councillors that Wychavon Planning had let down both the community and Wychavon District Council elected members. It was **agreed** to seek a deposition to address the next meeting of Wychavon Councillors to raise various issues including the detrimental effect of the merger with Malvern Hills Planning and the original Mitton Bank Memorandum of Understanding not being approved by members. On planning matters in South Worcestershire, it was felt that Wychavon had undertaken the brunt of the 'heavy lifting' over the last 10 years.

ii. Planning Inquiry Update:

The Planning Inspector was dis-satisfied that the submitted transport assessment had been undertaken using an insufficiently robust approach. This would be likely to result in a severe residual cumulative impact on the road network and might harm to the tranquillity of the AONB. For these and other matters raised during the Inquiry, the appeals were dismissed. The Council recorded thanks to Cllr Hardman for his major contribution to the positive outcome of the Inquiry.

iii. Ashchurch Bridge over Rail (ABoR):

Cllr Bradley will attend the Court of Appeal of the Judicial Review, with Cllr Tony Davies of Ashchurch Rural Parish Council, at the High Court in London, on 13th December 2022. If successful the planning application will be sent back to Tewkesbury Borough Council to reassess, noting both the comments, and ruling of the Court.

6. Playing Field Incursion Measures.

Cllr Falvey provided details and associated costs for height barriers and bollards and will progress the 106 funding applications. There is also a £1k grant option from Wychavon.

It was **agreed** to purchase two Height Barriers for the Main and Eckington Road car parks and one Retractable Bollard at the Playing Field end of the access route.

7. 'Local Live'.

Cllr Shiels requested that this item was deferred to the January meeting.

8. Progress Reports and Updates for Information.

- a) County and District Councillor:
 - A grant of £500 will be forwarded by Worcestershire County Council towards the cost of the Kemerton Road footway widening scheme for hedgerow replanting.
 - The revision to District Council boundaries means that the Westmancote polling (voting) will return to Bredon.
 - A reduction in speed limit, to create a buffer zone, on the Cheltenham Road (from 60mph to 40mph) is being investigated.
 - BT have undertaken damage repairs to the drainage in Bredon's Norton.
 - The County rate increase is expected to be 4.94%, to primarily cover Adult Social Care and District are expected to freeze their rate for another year.
 - Matt Hale will be asked to remove the dead tree near the Westmancote Bus Shelter, when working on-site for Kemerton Estate.
 - Eckington Parish Council have requested cooperation in responding to SWDP Travellers Sites.
- b) Police and Defibrillator:
 - There was a RTA at the Main Road/Eckington Road junction on Friday 9th November
 - Police have received complaints from residents relating to speeding /accelerating in Church Street, outside the school
 - Bredon Star RFC have secured grants for portable defibrillators, which will be available to the community for Playing Field events.

Working Groups:

- c) Transport & Organisations:
 - Next meeting scheduled for early January 2023.
 - Enerveo are fitting replacement LED streetlights, on the parish council's three lampposts, on 14th November 2022.
- d) Executive & Finance:
 - Next meeting on 14th December, primarily to discuss 2023-24 Precept which needs to be approved at January meeting.
