ii. Ashchurch Bridge over Rail (ABoR):

All three Court of Appeal Judges upheld the appeal on the three grounds and quashed the planning permission for the ABoR. It is expected that Tewkesbury Borough Council (TBC) will bring forward a further application at a future date, but the requirements of the judgement will need to be satisfied as part of any submission. A traffic data logger is required to check the Hardwick Bank Road traffic flows.

#### 6. Car Park Barriers and Bollards.

Cllr Falvey advised quotations have been received and circulated. It was **agreed** to purchase 2 x Green Height Restriction Barriers at £2514.83 plus VAT each and a Green Steel Assist Telescopic Bollard at £771.12 plus VAT.

  - The Pershore Rural North and South Safer Neighbourhood Team (Police) provided an update on the Castle View situation.
