# **Precept for 2023**

As a group of volunteers, the Parish Council serves its residents and defends their views and feelings, supports local initiatives and helps make our local community a better place to live.

To fund things like defending the appeal against Mitton Bank, which as I'm sure you are well aware solicitors and barristers are not cheap, we have to use money generated from the precept (a small part of your council tax).

The council receives grant funding for lots of the community projects, like our incredible playing fields, but these grants only fund a percentage of the overall cost, the remaining comes from the precept.

Over the last decade, we have frozen the precept, not charging our parishioners anymore. However, with prices of everything increasing, we have to make a small increase this year, of 5.47%.

This equates to only £2.49 per year, for a Band D property. Hopefully, you accept this as great value for the work we do for the community.
