Planning Applications

The Parish Council's role is only advisory. For more details, please refer to www.wychavon.gov.uk.

For consideration by Wychavon:

W/23/00453 - St. Catherines barn, Lampitt Lane, Bredon's Norton. Proposed greenhouse. **PC has no objection, subject to the Planning Officer being satisfied there is no impact on the Area of Outstanding Natural Beauty.**

W/23/00644 - Windermere, Cheltenham Road, Kinsham. Two single-storey dwellings. **The PC objects. This is over development of site and is not in keeping with Neighbourhood Plan. It will also have an impact on adjacent ancient monument and nearby listed buildings.**

W/22/01945 - The Cottage, Chapel lane, Westmancote. Alteration, refurbishment and extension of residential dwelling, including alterations to garden boundary treatment and provision of new vehicle access off Chapel Lane. **This was approved by the Wychavon Planning Committee.**

W/23/00405 - Castle View, Eckington Road, Bredon's Norton. Change of use from disused land to 5no. pitches for local travellers with 1no. static and 1no. touring caravan per pitch. (Variation to Condition 12 Ref. 19/01355/FUL) **The PC objects. This refers to a reduction of the approved landscape buffer zone from 20m to 10m (measured from highway). This 20m buffer was a condition of Wychavon Planning Committee's original approval.**
