Local Police engagement

The Police attended our Parish Council meeting and reported on the latest statistics and answered any questions we had.

They confirmed they have increased their patrols through the parish; they often stop and engage with any teenagers they meet loitering, building relationships to avoid antisocial behaviour; and they have issued multiple Community Protection Notice Warnings (CPNWs) to repeat offenders, these CPNWs have certain conditions on them.

They reiterated that please could people report any anti-social behaviour or criminal activity, and if they have any evidence, for example doorbell videos, please could they send any evidence to the Safer Neighbourhood Team:- pershorerural.snt@westmercia.police.uk

The police do not monitor or view social media, like the Bredon Parish Noticeboard, and any evidence or activity should be reported directly.

The Council are seeking advice from the police on potential CCTV, and also investigating alternative power sources and cameras.

We are going to suggest that the Safer Communities Team attend a public meeting, to give residents the opportunity to listen and raise questions.

W/24/00197 - Manor Farm House, Kinsham. Renovations and Alterations to Main House & Curtilage Listed Barn (Retrospective). **PC note changed internal configuration, but unable to comment as drawings provided are inadequate. Important the Conservation Officer's views should be taken into account.**

W/24/00162 - Box Cottage, Kinsham. Erection of single storey rear extension and garage terrace. **PC advises any approval should state the Extension/Garage should remain ancillary to the main building.**

W/23/02457 - Rose Cottage, Bredon's Norton. Removal of existing roof, introduction of breathable felt and replacement of existing roof. **PC has no objection.**
